The 2011 Advanced Placement (AP) exams will be given in Allegany County beginning on May 2nd, 2011. **For each AP exam your child plans to take, please complete and sign a separate copy of the permission form below and return it to the appropriate AP teacher by February 1st.** The cost is \$79.00 for each exam. There will be no cost for students who qualify for fee waivers (**eligibility indicated on the back**). Exams will be ordered on March 1st, 2011. Any changes or additions to tests after the first order will be an extra fee (\$40) responsible by the student. **Please make checks payable to your child's school.** Below are the dates for each test. **Testing times and dates are established by College Board and can not be changed.** A more detailed schedule will be sent home in April regarding specific locations and materials.
